Simpson Thacher and the Southern Coalition for Social Justice Overturn Unconstitutional North Carolina Law Criminalizing Voting

On April 22, 2024, Simpson Thacher and the Southern Coalition for Social Justice (SCSJ) secured a decisive victory for their clients in a federal lawsuit in North Carolina District Court challenging a North Carolina law criminalizing voting. The win overturned a racially discriminatory law that made it a Class I felony for North Carolina residents to vote if they are on parole, probation or post-release supervision for a felony conviction, even if they mistakenly believe they are eligible to vote. Virtually every other election crime punishable as a Class I felony in North Carolina requires intent. Under this strict liability law, there had been high-profile prosecutions which chilled countless eligible voters with criminal convictions from exercising their right to cast a ballot. This fear of prosecution impeded voter engagement efforts by the North Carolina A. Philip Randolph Institute and Action NC, who were the Plaintiffs in the suit. The lawsuit was originally filed in September 2020.

The team successfully argued that this law, which dates back to the nineteenth century, violated the Due Process and Equal Protection Clauses of the Fourteenth Amendment to the United States Constitution. In her decision, U.S. District Court Judge Loretta Biggs found it "extraordinary and telling" that the state did not dispute the discriminatory origins of the law or its current discriminatory impact on Black voters. She also noted that vagueness around the strict-liability nature of the law, enabled North Carolina district attorneys to "pursue their personal predilections" in deciding whether to enforce the law.

After Simpson Thacher and SCSJ moved for summary judgment, the North Carolina legislature amended the law on a prospective basis for elections after January 1, 2024. Simpson Thacher Obtains Appellate Victory and Five Year Final Order of Protection for Domestic Violence Survivor Client

Simpson Thacher secured vital protections for a domestic violence survivor in a successful appeal to the New York State Appellate Division: Second Department, which resulted in entry of a final, five year order of protection for the Firm's client, who suffered years of abuse at the hands of her ex-husband. Simpson Thacher had appealed the lower court's determination that only a suspended judgment should be entered in petitioner's case, rather than an order of protection, even though the court had previously found the petitioner's testimony credible about the physical injuries she suffered as a result of her ex-husband's attacks against her. These included when he used dangerous instruments to whip and strike her, sometimes in the presence of the parties' child. On appeal, the Second Department unanimously held, as the Simpson Thacher team had argued, that the ex-husband's acts of abuse constituted "aggravating circumstances" under the law, warranting entry of a five-year final order of protection rather than the suspended judgement.

Litigation Associate **Alison Sher** briefed the case and appeared at oral argument in the Appellate Division. Simpson Thacher Wins Two Year Sentence Reduction for a Client Suffering From Schizophrenia

On May 28, the New York Appellate Division, First Department, reduced our client's prison sentence for manslaughter in the first degree from 12 years to 10 years in the interests of justice. Our client has suffered from severe mental health issues, including schizophrenia, since he was a teenager. After experiencing physical and emotional abuse by his parents, he was placed in the foster care system. He eventually became homeless and went years without appropriate mental health treatment. He instead attempted to ease his pain with drugs and alcohol.

In 2017, our client suffered a psychotic episode in which he believed that another homeless individual had stolen his backpack containing his identification documents. He hit that individual in the head with a long metal object, which ultimately led to the individual's death. This incident was extremely out of character for our client, who had never previously been convicted of any violent offenses. Simpson Thacher and Civil Rights Groups Challenge Louisiana Law Mandating School Posting of Ten Commandments

Simpson Thacher, the American Civil Liberties Union, the American Civil Liberties Union of Louisiana, Americans United for Separation of Church and State ("AU") and the Freedom from Religion Foundation ("FFRF") filed a lawsuit on June 24, 2024, challenging a new Louisiana law requiring that the Ten Commandments be displayed in every public school classroom. The Complaint for Roake v. Brumley, filed in the U.S. District Court for the Middle District of Louisiana, asserts that the newly enacted statute violates longstanding U.S. Supreme Court precedent and the First Amendment. The Complaint further alleges that the new law "substantially interferes with and burdens" parents' First Amendment right to direct their children's religious education



and upbringing, and that, in approving and mandating the display of a specific version of the Ten Commandments, goes against the doctrine of separation of church and state.

The lawsuit, brought on behalf of a multi-faith group of nine Louisiana families with children in public schools, highlights the religiously coercive nature of the displays mandated by the new law. The complaint seeks a declaratory judgment that the law is unconstitutional and a permanent injunction to prevent its enforcement. London Office Launches New Weekly Clinic in Westminster

The London Office launched a new clinic in the spring of 2024 in partnership with the South Westminster Legal Advice Centre (SWLAC). The SWLAC Clinic operates weekly on Thursday evenings in Westminster and serves those living in the area who earn the minimum wage or are in receipt of benefits and cannot afford solicitor fees. Clinic volunteers offer general advice on matters relating mostly to housing, employment and family law. Simpson Thacher Paralegal Tilda Santin coordinates the Firm's schedule and provides invaluable assistance to the clinic's operations. Spotlight: 2024 Public Interest Summer Fellow, Marissa Bucci

Summer Associate **Marissa Bucci** will be working with a youth-focused Connecticut nonprofit organization called Domus as part of her 2024 Public Interest Summer Fellowship. Domus aims to provide community programs and training to



support at-risk youth, with a particular focus on workforce development, juvenile justice, youth violence prevention, and education. As part of her work, Marissa will conduct legal research for a new Connecticut law that seeks to expand access to diversionary alternatives for children who commit minor crimes. She hopes to speak with local attorneys in the immigration and public defense fields to gain insights on how the new law could impact undocumented youth and the current criminal legal system process. These opportunities will enable Marissa to create a legal memo for the new juvenile diversion law.

Simpson Thacher Team Completes Trial in Mississippi in First Amendment Challenge

Simpson Thacher and the ACLU of Mississippi challenged a Lafayette County, Mississippi permitting policy on First Amendment grounds. The Lafayette County Courthouse grounds have long been a site of protests, rallies and other community activities, including in the summer of 2020 protests and counter-protests regarding the Confederate monument on the Courthouse grounds. In July 2020, local documentary filmmaker, photographer, visual artist and educator, John Rash, applied for a permit to use the Courthouse grounds for his evening PROJECT(ion) event, a part of the annual Oxford Fringe Festival. Lafayette County subsequently amended its policies to prohibit all nighttime activity on the Courthouse grounds, along with other limitations, and denied Mr. Rash's permit. We are challenging the constitutionality of the permitting policies, seeking to ensure that Mr. Rash and his fellow Lafayette County citizens are afforded their full First

Amendment rights to engage in political speech in a public forum.

In August 2020, the Northern District of Mississippi denied our motion for a preliminary injunction. We subsequently amended the complaint and proceeded with discovery, including taking the deposition of several Lafayette County officials and law enforcement officers. In early 2021 the parties filed cross motions for summary judgment, which the court denied. After several trial postponements, in October 2022 the parties agreed to engage in renewed summary judgment briefing. In August 2023, the case was reassigned to a new judge and a trial commenced in early March 2024. The team put on 10 witnesses, did opening and closing statements and put in evidence. We expect a decision after post-trial briefing concludes. The team included Senior Counsel Janet Gochman, Associate Allison Draikiwicz, and Litigation Partner Jon Youngwood, who called the trial "An amazing adventure in what might be the federal courthouse in the poorest possible location in America."

Simpson Thacher Hosts In-Person Immigration Clinic in New York for 23 Community Members

On April 17, volunteers from Simpson Thacher, Morgan Stanley, and Apollo collaborated with Catholic Migration Services and New York Lawyers for Public Interest (NYPLI) to host a limited scope immigration screening clinic to help determine community members' eligibility for various forms of immigration relief. The participating teams were able to accommodate a range of different languages—including English, French, Spanish, Mandarin, Wolof and Pular. Together, volunteers interviewed 23 community members, many of whom have now worked with Catholic Migration Services to seek further assistance with their asylum applications as well as additional referrals and support.
