### From the Pro Bono Chairs: Recognition of 2016 Pro Bono Accomplishments and a Look Back

Thanks to you, 2016 was another terrific year for Simpson Thacher's Pro Bono practice. In addition to providing over 48,000 hours of legal services to poor and vulnerable communities, nonprofits and fledgling small businesses, the Firm won "Pro Bono Law Firm of the Year" from Law360, and received the President's Pro Bono Award

from the State Bar of California, both highly prestigious honors. As recent events have shown us, now more than ever there is a critical need for attorneys to provide effective representation to those who cannot defend themselves and whose voices are often unheard. We are proud of all of you who have been willing to be those voices, and hope everyone can find a way to continue to contribute to these efforts.

Throughout the year our pro bono volunteers were engaged in vital issues, in our own backyards and across the globe, through individual advocacy, policy, and litigation. We helped low-income individuals navigate complex benefits laws; challenged unconstitutional practices by government agencies; protected nonprofits that support education and the arts; and helped preserve human rights and the environment, to name just a few. This work has never been more important.

Earlier this month the Firm recognized many hundreds of its volunteers as Pro Bono Champions and Pro Bono Leaders. The two organizations which received the most votes were Kids In Need of Defense (KIND) and the American Civil Liberties Union (ACLU). Both organizations will be receiving a significant charitable donation from the Firm in honor of our volunteers.

#### Simpson Thacher Responds to Immigration-Related Executive Orders

#### Travel Ban Litigation

Simpson Thacher attorneys have been involved in numerous efforts nationwide in response to the President's Executive Orders relating to the entry of certain categories of aliens to the United States. The first Order, issued on January 27, 2017, entitled "Protecting the Nation from Foreign Terrorist Entry Into the United States," was challenged by numerous litigations around the country, found to be unconstitutional by several federal courts, including the 9<sup>th</sup> Circuit, and provisionally replaced on March 6<sup>th</sup> by a second Executive Order slated to go into effect on March 16th. Simpson lawyers are involved in three of these litigations, Washington v. Trump, filed in the Seattle District Court, Hawaii v. *Trump*, filed in the District of Hawaii Court, and *Pars* v. Trump, filed in the District of Columbia Court. Our attorneys represented immigration legal services nonprofits as *amici* before the 9<sup>th</sup> Circuit supporting the plaintiffs' efforts in Washington v. Trump to keep in place a nationwide temporary restraining order that prevented enforcement of the January 27th Executive Order. The Firm also represented a similar group of amici to support the plaintiffs' efforts in Hawaii v. Trump. Our representation of amici in Pars v. Trump is forthcoming. Our work in these litigations has been led by **Buzz Frahn** and **Alan** Turner. In addition, Buzz and a team of attorneys in Palo Alto have been providing a daily litigation summary to hundreds of nonprofits and others across the country regarding the more than twentyfive litigations challenging the Executive Order on a variety of legal grounds. Alan and a team in New York have been tracking immigration policy changes, which affect the Firm's many immigrant clients.

#### Airport Rapid Response

Simpson lawyers also provided on the ground assistance in the wake of the January 27th Executive Order. Over 30 of our attorneys spent multiple days at JFK, SFO and Dulles airports, or in support of those efforts, providing assistance to legal visa holders and others being detained at these airports as a result of the Executive Order. As a result of our work on the ground, the Firm engaged several U.S. citizen clients to assist them with bringing their families to California from Iran and Syria. These families, each with young children, had valid visas but were denied entry. In one family's case the denial meant they were stranded in Abu Dhabi for days on a layover on their way to the U.S. Two Simpson legal assistants in the Washington Office paid in-person visits to the California senators on the Hill to get the

matter escalated. With the Firm's help, all of these families were eventually able to be admitted to the U.S., and reunited with their relatives.

#### Hotline Assistance

Finally, the Firm has been assisting with three separate efforts to staff legal hotlines which have been set up to provide legal and know your rights information for the immigrant community. Simpson attorneys provided information on changes to immigration policy and did general intake interviews of callers. Our volunteers throughout the country have staffed the hotlines for the Legal Aid Society of New York, the New York Civil Liberties Union, and the Texas Immigration Rights Coalition/ACLU of Texas.

#### Simpson Attorneys Assist Harvard Law School's National Criminal Justice Debt Initiative

The Firm assisted Harvard Law School's Criminal Justice Policy Program with its National Criminal Debt Initiative. The initiative is part of Harvard's work to advance reform of policies for imposing fees and fines in the criminal justice system. With Simpson's help, Harvard created a searchable website to assist advocates dedicated to reforming how criminal justice debt is imposed and enforced on a national scale. The Director of the Initiative, Mitali Nagrecha, is a former Simpson litigation associate who was awarded a year-long Simpson Thacher Public Service Fellowship in 2010 to work on this issue. #### Simpson Thacher and Morgan Stanley Sponsor Equal Justice Fellow

In December 2016, Simpson Thacher and Morgan Stanley interviewed five candidates for an Equal Justice Works Fellowship to begin in the Fall of 2017. The Fellow will be Christopher Helwig, from Columbia Law School, who will work at Lenox Hill Neighborhood House. His project is to improve the lives of low-income elderly, disabled, and chronically ill tenants living in East Harlem public housing by fighting for their right to live in safe and habitable apartments. Chris will present his work at a joint event with Morgan Stanley in the spring of 2018.

#### **New York Office Clinics**

The New York Office held a number of clinics this winter. Two clinics involved helping low-income New Yorkers naturalize, the process by which eligible immigrants become U.S. citizens. More than nine million people in the U.S. are eligible to naturalize, but have not yet done so. Naturalizing brings important benefits to clients, including the right to vote, and protection from removal—a particular concern for low-income communities of color that are highly policed.

On December 20<sup>th</sup>, Simpson volunteers interviewed about 30 individuals to determine their eligibility to apply to naturalize. On Saturday, January 28<sup>th</sup>, Simpson attorneys staffed an all day, city-wide naturalization clinic, in partnership with New York Lawyers for the Public Interest and Catholic Migration Services, hosted by the Brooklyn Borough President. There, our attorneys were part of a volunteer group which assisted over 100 clients to prepare applications. Each client was a participant in New York City's Food Business Pathways Program, which helps public housing residents formalize their food-related businesses. #### Simpson Thacher Represents Amici Before the Supreme Court in Transgender Bathroom Case

Simpson Thacher filed an amicus brief in the United States Supreme Court on behalf of law professor Terry S. Kogan, Professor of Law at the S.J. Quinney College of Law, University of Utah, in the case Gloucester County School Board v G.G. The case was filed on behalf of a transgender high school student, and challenges a school board policy that prohibits him from using the boys' bathroom, requiring instead that transgender students use "alternative private" restrooms. Professor Kogan has studied the history of laws mandating sex-segregation in public restrooms in the United States. The amicus brief draws on that history to challenge two assumptions underlying arguments in support of the school board's policy: (1) that public restrooms are separated by sex because of anatomical differences between men and women and (2) that public restrooms have been separated by sex throughout history. Professor Kogan's research shows that the first laws mandating bathroom sex-separation were not adopted until the late nineteenth century, and that they were not motivated by anatomical differences between men and women but rather grounded in then-contemporary understandings of gender roles, and often enacted as amendments to existing protective labor laws aimed only at women and children. The brief argues that this history helps demonstrate that excluding transgender students from restrooms congruent with their gender identities is discriminatory.

In February, the Departments of Education and Justice revoked guidance upon which the Fourth Circuit had relied in ruling in G.G.'s favor. As a result, the Supreme Court vacated the Fourth Circuit's judgment and remanded the case after the amicus brief was filed. #### Simpson Thacher CIO Leads Pro Bono Technology Effort in New York State

In 2014, the Pro Bono Law Firm IT Initiative was created to enable senior information technology leaders from private law firms and elsewhere to develop a pro bono project that would utilize their technology expertise in assisting nonprofit civil legal aid providers. As a result of this effort, teams of pro bono IT professionals participated in a pilot project in 2015 with five civil legal aid providers. The IT volunteers conducted individualized evaluations and developed tailored recommendations for improving the technology infrastructures of these five nonprofits, including recommendations on software and hardware updates, security and technology policies. Following this success, the Initiative has expanded the project to legal services organizations throughout the state by offering a series of webinars to help participating civil legal aid providers understand the current state of its technology environment through a technology assessment, training sessions on individual technology topics. and guidance offered by pro bono IT professionals representing leading law firms in New York. The chair of the Initiative is Simpson Thacher's Chief Information Officer, Michael Donnelly, supported by the Firm's Pro Bono Counsel, Harlene Katzman.

### **Recent Pro Bono Achievements**

#### Simpson Thacher Wins Two Unemployment Insurance Appeals

Simpson Thacher won two hearings before the Unemployment Insurance Appeals Board. Both clients were referred by Volunteers of Legal Service's Unemployment Insurance Advocacy Project.

The first case overturned the Department of Labor's initial determination disqualifying him from receiving benefits; charging him with an overpayment of benefits; and imposing a civil penalty for alleged willful misrepresentation. The team included **May Mansour** and **Asher Lowenstein**.

The second case was on behalf of a client whose former employer challenged her eligibility for unemployment benefits with allegations that she committed misconduct in connection with her duties as a daycare teacher. Attorneys **Jillian de Chavez-**Lau and **May Mansour** successfully argued that none of the client's actions amounted to misconduct.

Both matters were supervised by Bryce Friedman.

#### Simpson Thacher Secures U Visa for Mexican Client After Successful Appeal

Attorneys in Simpson Thacher's Palo Alto office successfully appealed the U.S. Citizenship and Immigration Services' initial denial of U nonimmigrant status to a Mexico-born client. The client had suffered domestic violence and assisted local prosecutors in successfully prosecuting her abuser. But because of a confusingly written certification by the district attorney's office about the client's helpfulness in the prosecution, the USCIS denied the U visa petition in February 2015. Simpson Thacher filed an appeal and, in September 2015, the USCIS's Administrative Appeals Office reversed the denial. After submitting additional evidence to support a waiver of inadmissibility, the USCIS found the client eligible for U nonimmigrant status in March 2016. But due to a statutory cap, the client was placed on a waiting list. In March 2017, the client finally secured U nonimmigrant status, which can lead to permanent residency within three years. The team included associates Jonathan Mincer and Mike Joshi, with supervision from partner Alexis Coll-Very.

#### Simpson Thacher Successfully Helps Iranian National Obtain Emergency Visa

A U.S. permanent resident originally from Iran suffered a stroke and brain bleed, leaving him in critical condition in the intensive care unit at Stanford Hospital. Simpson Thacher attorneys, working pro bono, successfully helped the patient's brother—the patient's closest living relative—obtain an emergency visa to come from Iran to the U.S. to make medical decisions on his brother's behalf and provide emotional and physical support. Associates **Jonathan Mincer, Linda Nyberg** and **Andrew Simon-Rooke** assisted in the effort.

#### Simpson Thacher Featured at NYLPI Law & Society Award Luncheon

Simpson Thacher was featured at the twenty-fourth annual Law & Society Award Luncheon of New York Lawyers for the Public Interest (NYLPI) for its role in advocating to secure immigrant detainee rights to mental health discharge planning. In July 2016, Simpson and NYLPI filed a federal lawsuit against Orange County, NY and other county departments and officials for their failure to provide discharge planning, a plan to ensure that mental health care does not lapse upon release, which is widely regarded as an essential component of mental health care. Without discharge planning, people with mental illness face an array of grave consequences when released from immigration detention. The Simpson Thacher team includes litigation partner **Tom Rice**, who also serves on NYLPI's Board of Directors, and litigation associates Daniel Stujenske, Lauren Repole and Esinam Agbemenu, all of whom were featured in a video about the litigation.

#### Simpson Thacher Receives Pro Bono Leadership Award from Legal Services-NYC

Simpson Thacher will receive the Pro Bono Leadership Award from Legal Services-NYC for being one of its top pro bono partners in 2016 and for the Firm's long-standing support of its work and its clients. The award will be presented at its annual Jazz for Justice event at Cipriani 42nd Street on March 29, 2017.

#### Simpson Thacher To Receive 2017 Pro Bono Counsel Award from the National Law Center on Homelessness & Poverty
