# Simpson Thacher, Along With the ACLU of Mississippi and the ACLU, Secure Landmark Consent Decree in Unconstitutional Policing Lawsuit

On October 3, 2019, the United States District Court for the Southern District of Mississippi approved a groundbreaking consent decree that will help to prevent Mississippi's Madison County Sheriff's Department (MCSD) from engaging in racially motivated policing practices. The class-action lawsuit, *Brown vs. Madison County*, filed by Simpson Thacher, the American Civil Liberties Union and the ACLU of Mississippi, aimed to challenge Madison County's unconstitutional policing tactics. The approved decree implements several reforms to existing procedures and includes new policies that amend the pedestrian stops and checkpoints of the MCSD. *Brown vs. Madison County* is one of the first consent decrees in the state of Mississippi to address racialized policing.

Partner **Jonathan Youngwood**, who led the Simpson Thacher team, was recognized as an AmLaw Litigation Daily "Litigator of the Week" finalist for his work in this case. The consent decree was covered by publications including *The New York Times*, *WJTV*, *Mississippi Public Broadcasting*, *Bloomberg Law's Big Law Business*,

Reason, Clarion Ledger, The Appeal, The Root and WLBT, as well as several other publications and broadcast outlets.

# Simpson Thacher Attorneys Travel to the U.S.-Mexico Border to Assist Detained Immigrants

Litigation Partners Brooke Cucinella and Stephen Blake, and LatAm Associates Luis Pellerano and Joshua Bernard spent a week in August interviewing and preparing recently detained asylum seekers for their asylum claims at the Port Isabel Detention Center in Los Fresnos, Texas. Simpson Thacher is the first law firm to take on direct representation of detained clients through a program organized by the South Texas Pro Bono Asylum Representation Project (ProBAR). During the trip, the attorneys engaged two asylum seeking clients for full representation before the Immigration Court, and organized and carried out a humanitarian mission across the border in Matamoros, Mexico. Associate Dan Owsley has also recently joined the New York team.

The two asylum clients faced dire circumstances in their home countries, including gun violence and beatings by police – one persecuted for his political views, and the other because of his identity as a gay man. Both men also faced incredibly difficult circumstances in the temporary detention centers at the border, where both endured long term stays - despite a purported limitation that no one would be housed in the temporary facility for more than 72 hours. One client spent 38 days in the temporary facility – colloquially known among the detainees as the "dog pound" or the "chicken coop"—and had no access to soap, a toothbrush or a shower throughout that period. The second client contracted mumps, which went untreated and left him deaf in one ear, sterile, and in great pain.



The Simpson attorneys were accompanied Judy Perry Martinez and Patricia Refo, the President and President-Elect of the American Bar Association, on their humanitarian trip across the border to Matamoros, Mexico where they delivered to the men, women, and children affected by the Administration's "Remain in Mexico" Policy homemade hygiene kits they had purchased and packaged in Texas. The individuals they delivered these kits to attempted to present themselves for asylum in the United States, but were "returned to Mexico" and are living on the streets with virtually no food or potable water as they await the opportunity to file for asylum in the U.S.

### Simpson Thacher Secures Preliminary Injunction Blocking Fast-Track Deportation Rule

On September 27, the U.S. District Court for the District of Columbia granted a preliminary injunction blocking the federal government's new rule that sought to expand fast-track deportations without legal process such as a court hearing or access to an attorney. The expanded expedited removal rule was announced on July 23 and was scheduled to go into effect as soon as September 27. It targeted

immigrants nationwide who cannot prove they have been in the U.S. continuously for at least two years. Previously, the expedited removal of immigrants was limited to a 100-mile zone from the border, to those who arrived by sea, and to those who had been in the U.S. for 14 days or fewer. Simpson Thacher, together with the ACLU and American Immigration Council, filed a federal lawsuit, *Make the Road New York v. McAleenan*, on behalf of immigrant community organizations Make the Road New York, LUPE (La Unión del Pueblo Entero), and We Count! challenging the July 23 rule and seeking the preliminary injunction.

The decision was covered by *The Hill, NPR, Bloomberg Law: Big Law Business, The National Law Journal* and *Law360*. #### Simpson Thacher and NYLPI Secure Favorable Settlements on Behalf of Former Immigrant Detainees


Simpson Thacher, along with co-counsel New York Lawyers for the Public Interest (NYLPI), secured favorable settlements on behalf of two clients, Plaintiffs Michelet Charles and Carol Small, in connection with their claims against U.S. Immigrations and Customs Enforcement (ICE) and Orange County, New York and related entities (Orange County). Plaintiffs' claims arose from ICE's and Orange County's failure to provide discharge planning to them while they were held in immigration detention. Discharge planning is widely recognized by medical professionals as a basic and essential component of adequate mental health care, particularly in institutionalized settings.

Plaintiffs were both diagnosed with mental illnesses while confined to immigration detention and under ICE's and Orange County's custody. Plaintiffs alleged that ICE's failure to ensure the provision of discharge planning constituted (at a minimum) negligence in violation of the Federal Tort Claims Act. Plaintiffs' claims against Orange County were brought under Section 1983 of the Civil Rights Act for deliberate indifference to serious medical needs.

Simpson Thacher and NYLPI litigated these cases for more than three years, including obtaining a key decision from the Second Circuit in a case of first impression, establishing that a failure to provide discharge planning can constitute a violation of detainees' due process rights under the Fourteenth Amendment. After months of negotiation, ICE

and Orange County agreed to settle the cases for \$825,000 and \$900,000, respectively. The Simpson Thacher team includes **Tom Rice**, **Dan Stujenske**, **Esinam Agbemenu** and **Rick Walker**.

#### New Pro Bono Clinic: Screening Immigrant Children With Safe Passage Project

On September 19, 2019, Simpson Thacher launched a new pro bono clinic with Safe Passage Project, conducting intake screenings with undocumented children under 18 years of age who were apprehended at the border without a parent, to assess whether immigration relief is available to them. At this inaugural clinic, Simpson and Blackstone volunteers were able to screen 28 children, many of whom can now be matched with free attorneys, so that they are not forced to appear in Immigration Court without counsel. The Firm has agreed to host these

screenings with Safe Passage Project every other month going forward into 2020. #### Simpson Thacher Partner Co-Chairs New York State Task Force on Parole Reform

Partner Bill Russell was asked by the New York State Bar Association President Hank Greenberg to co-chair a task force to examine the issue of parole reform in New York and come up with a set of policy recommendations. New York currently sends more parolees back to prison than any other state in the union other than Illinois. While the state legislature has recently enacted reforms with respect to the bail process and pre-trial criminal discovery, there has not been a recent comprehensive review of the parole system in New York. The work of the task force is aimed at improving the administration of justice in New York, particularly with respect to people of limited means who make up the vast majority of individuals on parole.

#### Simpson Thacher Attorneys Honored at 2019 Pro Bono Publico Awards

Counsel Isaac Rethy and Associate Magdey **Abdallah**, along with the Firm, were honored by the Legal Aid Society of New York as a part of its 2019 Pro Bono Publico Awards. Isaac and Magdey were recognized for their work on behalf of an immigrant with mental illness in removal proceedings. Legal Aid annually recognizes the outstanding work of its volunteers—which include lawyers and law firms, among others—who contribute their time and talent to provide legal services to low-income New Yorkers. The awards ceremony took place on October 28 at the Prince George Ballroom in New York.

#### Simpson Thacher Honored by Animal **Legal Defense Fund**

Simpson Thacher was awarded the 2019 "Advancement in Animal Law Pro Bono Achievement Award" by the Animal Legal Defense Fund (ALDF). The award recognizes the Firm's dedication of pro bono hours in helping the ALDF achieve its mission of protecting the lives of animals through the legal system. The Firm, on behalf of the ALDF and The Humane Society of the United States, sent a complaint to the Federal Trade Commission urging investigation into and enforcement against the deceptive "pet leasing" industry. Thanks in part to the complaint, an increased awareness about pet leasing has resulted in the banning of the practice in multiple states, including California, Indiana, Nevada, New Jersey, New York and Washington.
