With the recent initial public offering of Fortress and Blackstone and the launching of "permanent capital" vehicles by KKR and others, the private equity industry has attracted enormous amounts of attention from the press, investors and, increasingly, the governmental and regulatory authorities worldwide. Fundraising also set records in fund size, while the deals being done by the funds involved companies that were household names in and outside the U.S. During the height of this fundraising and deal-making environment, the problems with the subprime loans triggered a tightening of the credit markets that has had significant impact on the activities of the private equity funds.

At this two-day program, a distinguished panel of experts will discuss the basics of the private equity practice from fund formation to the fundamentals of private equity investing.
